

NOTICE TO PROPRIETOR(S) LIABILITY FOR BANNING SELF-DEFENSE

NOTICE TO AGENT IS NOTICE TO PRINCIPAL

Your establishment is most-likely taking on liability by prohibiting weapons.

The United States is a society where firearms are very prevalent. It is estimated that over 500 million firearms are in private ownership in the USA. Each day the number of firearms under Citizens' ownership increases. Many of these firearms are carried, and it is a protected right to do so in public. This right stems from the fundamental human right to individual self-defense and collective defense.

Your establishment is most-likely taking on additional liability to protect patrons by prohibiting patrons from carrying firearms. It is well-established that murderers and other violent criminals do not obey laws or signs. By prohibiting the carrying of weapons, you are rendering non-criminals less defensible from violent criminals. This is very suggestive of taking on an extra duty to protect occupants with armed and properly-trained security personnel.

May be brought up in suit:

- Failure to protect the individual(s) who were injured by a criminal.
- Posting of signs that encourage criminals by signaling that victims are defenseless.
- Unreal expectation of violent criminals to obey signs that prohibit weapons.
- Failure to provide appropriate amount of armed and properly-trained security personnel to protect mandated disarmed patrons in a highly-armed society.
- Not thoroughly checking all patrons with metal detection and/or comprehensive search to ensure no weapons are present.
- The US is a highly-armed society where carrying weapons is a protected right.
- Armed self-defense is a right and valuable and effective in a highly-armed society.
- **You were put on notice of these concerns and failed to act appropriately.**

Some attorneys give poor legal advice.

Some insurance companies are motivated by "ESG" and other initiatives to attempt to reduce gun ownership and use in the USA. It is not sound logic to think

liability will be reduced by bringing up in court the fact that a sign was posted or a policy against crime existed. Juries will instead look at the fact that self-defense was prohibited – combined with inadequate armed security personnel in an armed society – and assign more duty and liability.

History is full of examples of criminals choosing "posted" sign properties over non-posted properties.

Gun owners across the country are actively seeking plaintiffs who have been injured on public or private "gun free" property. Self-defense advocates are requiring establishments to respect the right or provide adequate armed security. You are encouraged to reverse any policies and remove all signs that prohibit weapons and instead defer to state law and a hands-off approach to self-defense. You have been warned on record of the concerns above should any injuries take place on your property while anti-self-defense policies are in place. This is not legal advice.

NOTICE TO PROPRIETOR(S) LIABILITY FOR BANNING SELF-DEFENSE

Instructions for service to property owners/lessees:

- 1) Be sure to follow state laws, avoid checkout areas in stores, avoid private conversations, notify the agent of the corporation that you are recording.
- 2) Always be polite: allowing negative emotions to affect delivery of information does not make that information more digestible to others.
- 3) Use a video camera and clearly record the notice immediately prior to handing the notice to employee (agent) of the entity. Capture the face of the employee and the acceptance of the legal notice by the employee.
- 4) You may, if you wish, explain to the employee what it is about. Friendliness and courteousness (positive) are much more effective than negative emotion expressions.
- 5) Our goal is to help create a safer society by encouraging people to remove ignorant signs and abolish ignorant and foolish policies. We will also seek to discourage these dangerous signs and policies through legal action by victims.
- 6) Now that there is a record of delivery of this information, we should publish it on the Internet to make it easily accessible. Should the entity you served not take proper action and subsequently have someone criminally injured on their property, they will most-likely face additional liability in court.
